1. Acceptance of Terms

By accessing and using Rustiriko's services, you agree to comply with and be bound by these Terms and Conditions. We reserve the right to modify these terms at any time. Continued use of our services after changes implies acceptance of the new terms.

These Terms and Conditions of Use ("Terms" or "Terms and Conditions") govern your use of the <https://www.rustiriko.com.au> website, our Rust servers, our digital VIP service, all content and software associated with our service, or any other service (each, or collectively, the "Service") provided by Rustiriko ("Rustiriko", "us", "we", or "our").

2. Services Provided

Rustiriko offers hosting services for Rust game servers, including optional VIP subscriptions, which allow queue bypasses. VIP subscriptions are non-transferable, tied to a single SteamID64, and specific to individual servers.

3. Account Terms

You must be at least 16 years old or the age of majority in your state or territory to use our Service. If you are under 16, you may use our Service only with parental or guardian consent and under their account.

You are responsible for maintaining the security of your account. Rustiriko cannot be held liable for any loss or damage from your failure to comply with this security obligation.

You must provide a valid email address and any other requested information to complete the signup process. Your login may only be used by one person – shared logins are not permitted.

4. VIP Subscriptions

- **Payment and Cancellation:** VIP subscriptions are billed on a recurring basis. You authorize Rustiriko to charge your provided payment method for each billing cycle. Cancellations can be made through our [members portal](#), with access retained until the end of the current billing cycle.
- **Restrictions:** Subscriptions are limited to one SteamID64 and are non-transferable. VIP access is server-specific, requiring separate purchases for each desired server.
- **Price Changes:** We reserve the right to change our subscription plans or adjust pricing at any time. Any changes will apply from the start of your next billing cycle, and we will provide notice of such changes.

- **Subscription Length:** VIP subscriptions are valid for 30 days from the date of purchase.
- **Refunds:** Subscription fees are non-refundable, and there are no refunds or credits for partially used periods.
- **Automatic Renewal:** By purchasing a VIP subscription, you acknowledge that you will be subscribed to a recurring renewal subscription fee as stated on the checkout page before your purchase is confirmed.

5. Privacy

Personal information provided during transactions is managed according to our Privacy Policy and is only used for account management and customer support.

6. Conduct

Users must follow respectful conduct and refrain from cheating, harassment, or disruptive behaviors while on our servers. Violations may lead to account suspension or ban without refund.
